




## **Mnaasged Fall Feast**

## Jordan's Principle Updates - Progress on 2025 CHRT 80 **Long-Term Reform Workplan**

The First Nations Child and Family Caring Society, working in close partnership with the National Children's Children's Chiefs Commission (NCCC), is actively advancing the long-term reform of Jordan's Principle as directed by the Canadian Human Rights Tribunal in 2025 CHRT 80.

Despite severely constrained funding, First Nations leaders, Jordan's Principle coordinators, community experts, and knowledge-keepers from coast to coast to coast have generously contributed their time and expertise throughout the fall of 2025.

Engagement materials were widely distributed through regional organizations, social media, QR codes, and direct presentations. A national webinar held in October attracted more than 200 participants and featured live facilitated Q&A with simultaneous Anishinaabemowin, Inuktitut, French, and English interpretation.



QR Code Caring Society Update to the CHRT November

#### Key milestones achieved to date:

- All engagement materials finalized and released by October 1, 2025
- Community and regional engagement sessions concluded on November 15, 2025
- Data analysis, led by an independent Indigenous scholar under the direction of the Caring Society and NCCC, is now well underway

Due to limited resources, many regions self-organized their own reform forums; the Caring Society was still able to attend and support 11 regional sessions since the last Tribunal update. The final consolidated Jordan's Principle long-term reform plan, incorporating the voices and priorities heard throughout this national engagement process, is on track for submission to the Canadian Human Rights Tribunal by December 22, 2025.
